District X Dual Meet Team Championships will be held on Tuesday, January 27th, 2009 for AAA at Edinboro University and Thursday, January 29th, 2009 for AA at Edinboro University. Four teams in AA and four teams in AAA will compete in the one day championship.

Since some teams are good tournament teams and not good dual meet teams, participation is strictly voluntary. Also, because many regions are not yet completed, entry into the championships will be by invitation once the following information is received:

1. You wish to participate in the team championships.
2. You feel you have a good balanced team to compete.
3. You submitted up to date dual meet scores of all dual meets wrestled prior to January 21st, 2009
4. You submitted your place finish in all tournaments prior to January 21st, 2009

Schools that are selected will wrestle at 5:00 p.m. on their scheduled date and the two winning schools will wrestle again at 7:00 p.m. for the championship.
