The following highlights the District ten meetings of April 2nd and May 7th 2008

ADMINISTRATION

- ❖ **Chairman Blucas offered appreciation and thanks to, winter tournament directors and staff. (April)**
- ❖ **The committee approved special awards, which were presented at the April Banquet.**
- ❖ **The committee reviewed the annual banquet and elections of officers. It is noted the present slate has been re-elected for the coming year. (May)**
- ❖ **The committee discussed and approved broadcast fees for wrestling team and individual tournaments: For team wrestling:**
- ❖ **Single dual-\$100.00, double dual-\$150.00 for individual sectional tournament-\$150.00 total, and for District individual tournament-\$150.00. (April)**
- ❖ **The committee discussed and approved fees for the official's conference. To provide \$200.00 to first time attendees with a cap not to exceed \$5000.00. (May)**
- ❖ **A report was presented by the Ad-hoc committee on Officials fees. After much discussion the fee proposal as presented was approved. (May)**
- ❖ **Chairman Blucas appointed an Ad-hoc committee under the direction of Dr Iacino, to review Honorariums for tournament directors, Officers, and special appointees. The report will be presented at the August Workshop. (May)**
